## **REGISTRATION Procedures, Fees and 2018 CRITERIA for BOLAND SCHOOLS TEAM**

### **REGISTRATION:**

- Registration Fee **TRIALS** – Schools, **R5.00 per Athlete**
- Registration Fee **CHAMPIONSHIPS** – Schools, **R10.00 per Athlete**
  
- Registration Fee **TRIALS** - Club Members, **R10.00 per Athlete**
- Registration Fee **CHAMPIONSHIPS** – Club Members, **R20.00 per Athlete**
- **Club Members** must also be in possession of a **CLUB LICENCE Number** for their results to be processed.

**\*NB: Registration takes place on the Morning of the Event at the Venue**  
(Registration of Athletes to be done on the attached Registration Form)

### **CRITERIA FOR BOLAND SCHOOLS TEAM (MAIN STREAM & LSEN):**

- In **selection** the **Boland Cross Country Team** for the 2018 Western Cape Cross Country Championships, the **Boland Schools Cross Country Selectors** will consider **Athletes** who have **achieved qualifying Positions and Times**.
- Athletes will qualify for selection provided they have **completed 4 (four)** out of the **6 (six)** of the **2018 Boland Athletics Cross Country Trials, plus the Boland Athletics Cross Country Championships**.
- Athletes from the **OVERBERG DISTRICT** and the **WEST COAST DISTRICT** are **obliged** to participate in **TRIAL 4 (2018 Boland Athletics Cross Country Inter-District Event)** and the **Boland Athletics Cross Country Championships**, and must **submit the Results** of at least **4 (four)** of the **Trials** run in their District.
- Athletes who were **sick or injured** during the **2018 Boland Athletics Cross Country Trials and Championships**, will be considered for the **Boland Schools Cross Country Team**, provided a **Medical Certificate** was **submitted** to the **Vice Chairperson or Registrar** of **Boland Schools Cross Country** before or after an event. Consideration will be **based** on the **performances** of the Athlete leading up to the **2018 Boland Athletics Cross Country Championships**.  
**Final selection in such cases will be subject to proof of illness or injury**

- Athletes participating at **Provincial** or **National** Events on the same day as the **2018 Boland Athletics Cross Country Trials or Championships**, will also be considered for the **Boland Schools Cross Country Team**, provided **Proof of their participation** was **submitted** to the **Vice Chairperson** or **Registrar** of **Boland Schools Cross Country**. Consideration will be **based** on the **performances** of the Athlete leading up to the **2018 Boland Athletics Cross Country Championships**.  
**Final selection in such cases will be subject to proof of participation at such events.**

#### **GENERAL CRITERIA:**

- The **final selection** of the **Boland Schools Cross Country Team** is subject to the final approval of **BOLAND ATHLETICS**.
- In selecting Athletes for the **Boland Schools Cross Country Team**, priority will be given to the selection of athletes with the **potential** to **qualify** for **SASA National Cross Country Championships** and to **win medals** for Boland Schools Cross Country / Boland Athletics at the **Western Cape Cross Country Championships** as well as the **SASA National Cross Country Championships**.
- Athletes who **do not achieve** Boland Schools Cross Country **Qualifying Positions** and **Times / Standards** will be selected onto the Final Team at the **discretion** of the **Boland Schools Athletics Executive** and **Boland Athletics**. In doing this the Boland Schools Athletics Executive and Boland Athletics will take the following **factors in consideration**, in the **specified priority order**:
  1. **Potential** for a **Medal** or **potential** to end up in the **Top 10**.
  2. **Demographics** of the Team.
  3. **Development** in general.

#### **APPEALS:**

An Athlete **not in the Team** when it is **announced** has the **right to appeal in writing** for **consideration** to be included in the Final Team. The appeal must be made to the **Vice-Chairperson, Boland Schools Cross Country** at [gric02@telkomsa.net](mailto:gric02@telkomsa.net) / [gprick60@gmail.com](mailto:gprick60@gmail.com) within **48 hours** after the announcement of the Team. The appeal should include all information the Athlete considers **relevant** to the Selection Panel's reconsideration of its decision.
